Program Area Managers are able to ensure programs, and their equipment are ready for the season as well as for each group/session. Ability to assess area and equipment readiness as well as train and assess seasonal staff are essential skills for the role

- Train and assess seasonal staff members to operate specific program area
- Judge when program equipment must be removed from operation and repaired or replaced

- Occasionally teach and facilitate activities in assigned program area(s)
- Joyfully and flexibly support day-to-day needs at camp
- Support the mission and vision of Sylvaneers at Camp Santa Maria
- Communicate activity, equipment, staff, or other program challenges and progress to the appropriate camp director
- Communicate effectively with seasonal staff responsible for running specified activity areas.
